

## California Consumer Privacy Act (CCPA)/California Privacy Rights Act (CPRA) Policy and Notice of Collection of Personal Information

Envoy Mortgage Ltd. may collect the following categories of personal information (“PI”) about you:

## **CA Residents' Rights under California Consumer Privacy Act (CCPA)/California Privacy Rights Act (CPRA)**

California residents have certain rights under the CCPA/CPRA:

- **Right to know how PI is obtained and used – “Right to Know”**

You may request that Envoy disclose what PI it collects, uses, discloses, and sells.

- **Right of Access to PI**

You may request that Envoy disclose to you the categories and specific pieces of personal information that it has collected and provide you with access to that information.

Upon receipt of your request to access your information, Envoy will provide you with copies of your mortgage loan origination file and your loan servicing file.

- **Right to Delete or Correct inaccurate PI**

You may request that Envoy and its service providers delete your PI. You may also request that Envoy and its service providers correct inaccurate sensitive personal information.

Please note that there are a number of exemptions to that permit lenders to retain information even when you request that it be deleted including, but not limited to, an exemption for information collected in connection with a financial product or service under the Gramm-Leach Bliley Act and information obtained from or provided to credit bureaus under the Fair Credit Reporting Act, or where information is required to be collected or shared under federal law, or where we need such information in order to service your account.

Examples of data that may be deleted upon request includes: information in Envoy's marketing systems and data collected about your interactions with our website or mobile app.

- **Right to Opt Out of Sale and Sharing of PI**

Envoy has not sold any PI in the last 12 months but has shared your data with third party service providers and vendors to market Envoy's products or services to you and to facilitate the origination of your mortgage loan.

You have the right to opt out of the sale or sharing of your personal information. Envoy's policy expressly prohibits the direct sale of your PI. Please note that certain marketing activities may constitute a “sale” under the CCPA/CPRA definition, so out of an abundance of caution, Envoy is providing you with an opportunity to opt out of marketing and to request deletion of your data with Envoy's third-party marketing vendors with whom Envoy may have shared your data.

Envoy will treat an opt out request as a request for deletion and will delete your personal information from our marketing platforms and will request that Envoy's third-party vendors delete your PI as well. Consumers should use the 800 number or website form (listed below) to make this request.

The categories of vendors that Envoy discloses or shares personal information with include the following:

- Third party vendors who provide marketing services for Envoy to market Envoy's products to you.
- Credit reporting agencies, automated underwriting systems, the IRS, fraud identification vendors, mortgage insurance companies, etc. in order to access their programs and facilitate the mortgage transaction that you requested.

Envoy does not offer financial incentives to consumers in exchange for sale of their personal data.

Envoy does not knowingly collect data from persons under age 18 and does not sell or otherwise share minors' information that may be collected incidental to the mortgage transaction (such as on tax returns) with any third party unless such third party is assuming a lender or servicer relationship with the borrower, or as otherwise required or permitted by law.

- **Right to limit use and disclosure of Sensitive Personal Information (SPI):**

You may restrict and limit the use and disclosure of any Sensitive Personal Information Envoy collects.

- **Right to Designate an Authorized Agent**

You may designate an authorized agent to make a request under the CCPA/CPRA on your behalf. In order to designate an authorized agent, the consumer must send a signed written authorization form to one of the following contacts:

- **Right to Non-Discrimination**

You have the right not to be discriminated against for exercising the privacy rights conferred by the CCPA/CPRA.

## How to Exercise your Rights under the CCPA/CPRA

So that we can verify your identity in connection with your request, please be prepared to provide the following information when you make your request:

- Name
- Address
- Loan Number or last 4 digits of the Social Security Number (if you are a borrower or have applied for a loan)
- Email address
- Telephone number

Envoy will acknowledge the receipt of your request within 10 days, and provide a response within 45 days, unless we let you know more time is needed.
